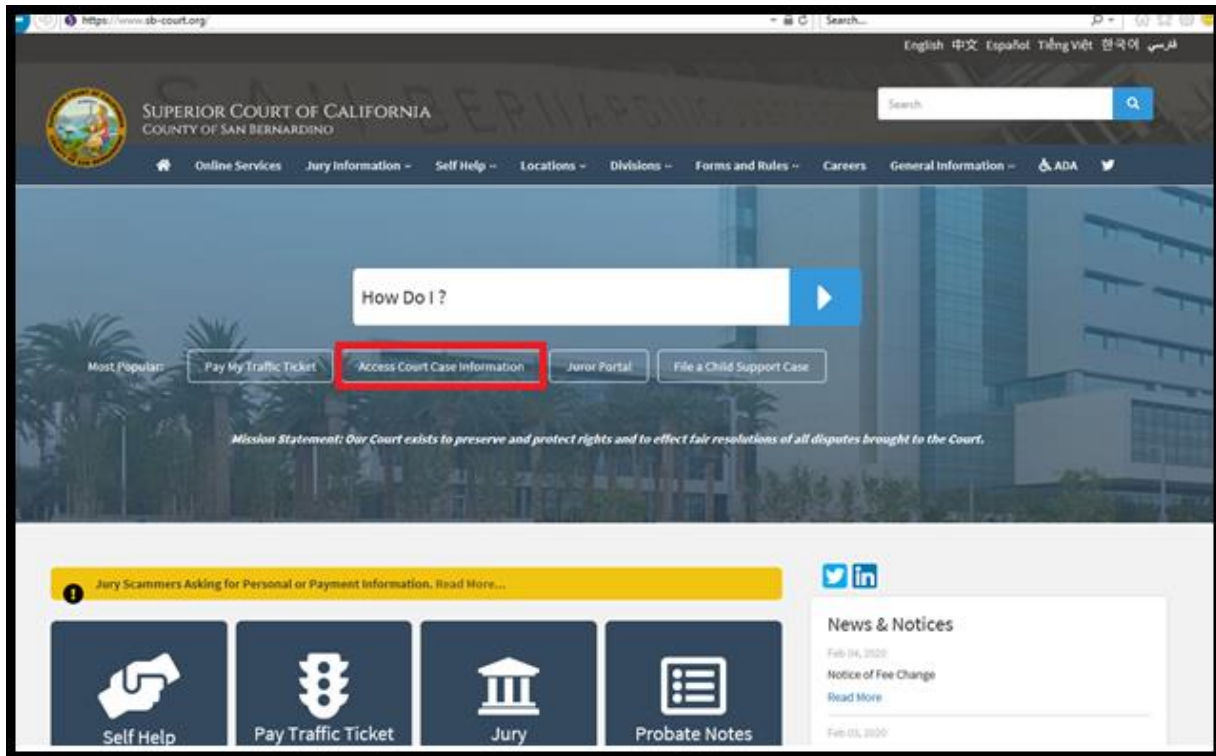
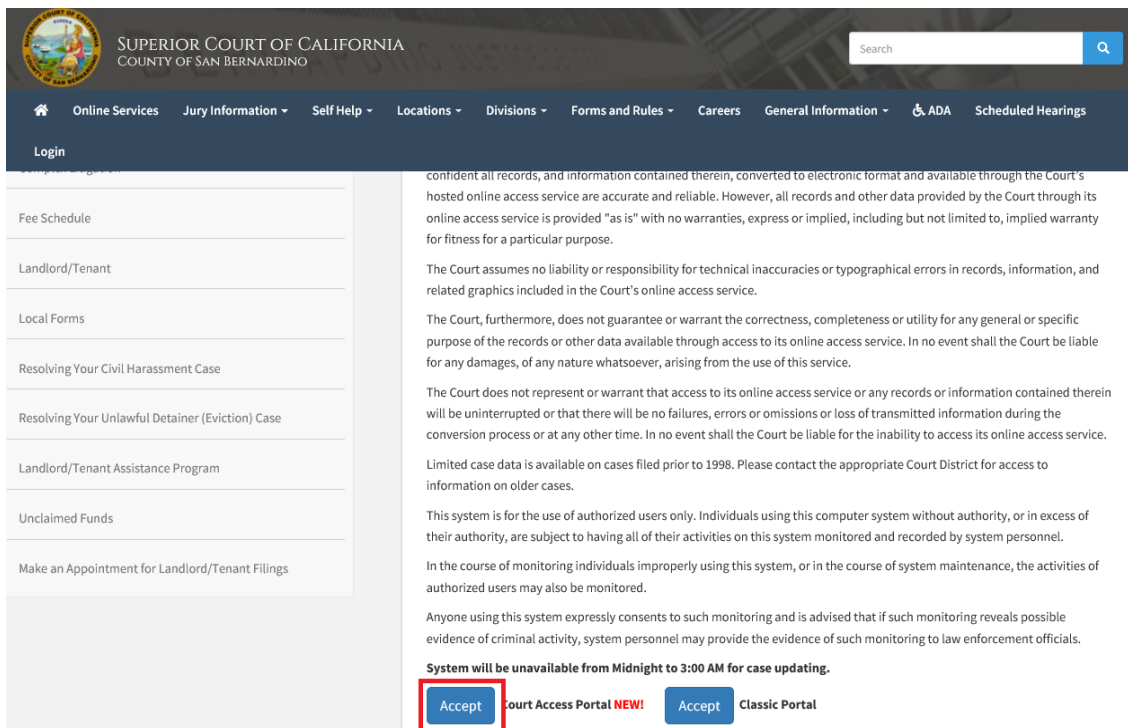


## Court Access Portal – Advanced Search – Justice Partners
